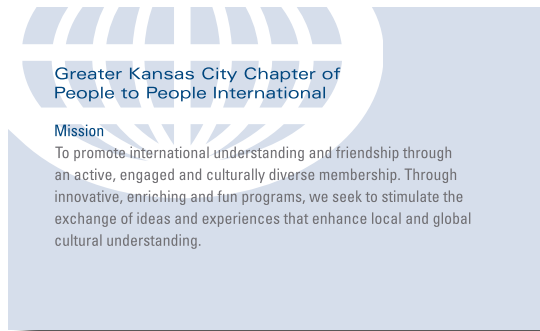

The United Nations Association of Kansas City (UNA) has announced that long-time Greater Kansas City People To People (GKCPTP) member Jim Malouff will be presented the UNA's World Citizen of the Year award at the Mayor's Annual UN Day Banquet on October 24th. The event will be held at UMKC's Pierson Auditorium, with a reception beginning at 6:30 p.m. and dinner at 7:00.

Jim's fingerprints are all over the international scene of Kansas City. Apart from accepting GKCPTP committee assignments and hosting foreign military officers, he is also a Trustee of People to People International. Jim has been involved with Sister Cities Association of Kansas City for nearly 25 years; he often provides hospitality to visitors through the International Visitors Council and is a regular participant in numerous charitable and educational activities involving our greater world.

You will soon be able to see tangible evidence of Jim's enthusiasm for making Kansas City a player on the world stage. This fall, Grand Boulevard from south of Crown Center to the River Market is being re-named Grand Boulevard of the Americas and will be festooned with the flags of virtually every country in the Organization of American States (OAS), some 34 flags in all. It wouldn't have happened without Jim coming up with the idea and personally lobbying for it with city officials and businesses along the route.

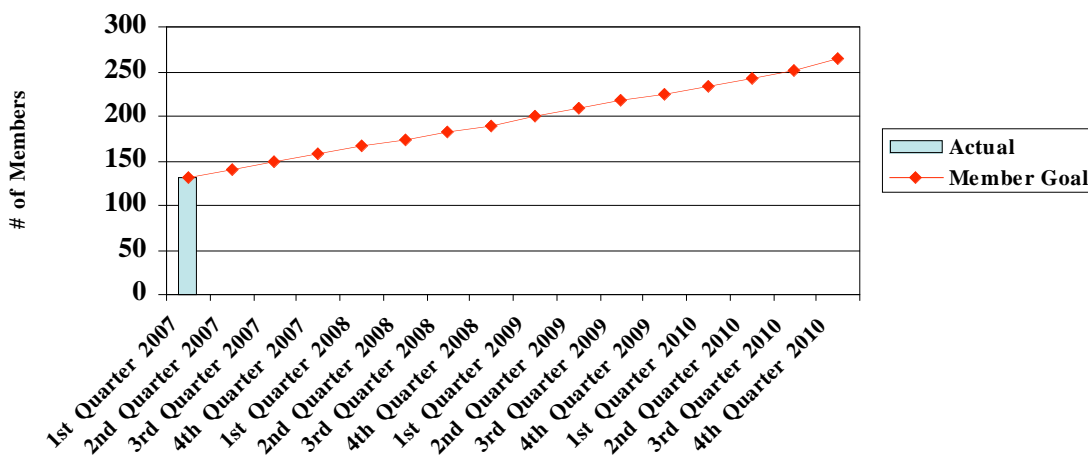
Strategic Planning Committee



One of the objectives the GKCTP board set for itself this year was to develop a new mission statement. The board wanted a statement that would offer a clear vision of what we wanted to be as an organization and how we would get there. **Nelson Markel** and his committee developed eight specific targets and goals to help us “get there.”

- Double chapter membership by 2010
- Develop “sister chapter” relationships with two (2) foreign chapters by 2010
- Establish a relationship and joint programs with a student chapter of PTPI in our metropolitan area by 2008
- Put in-place the staff and committees required to support a larger, more involved, organization
- Entice at least 33% of the members who are active in the sponsor program to become more involved with other chapter programs and events by 2011
- Develop two (2) additional programs and/or recurring events by 2009 that have significant value propositions and drawing power, that entice prospective members to join us, and encourage present members to retain their memberships
- Establish a program to develop future leaders for the chapter
- Develop a comprehensive communication plan, by the end of fiscal year 2007, to enhance our internal communication with members and our external communication to targeted constituencies.

The ongoing task for the board is to ensure that progress is being made towards achieving those targets and goals. Nelson proposed a system to track our efforts. He developed a graph for each target or goal that will track milestone achievements along the path to completion. Monthly updates will be provided to the board. Below is an example of the graph for membership growth.

Opportunity Available – Student Loan Coordinator

As many of you are aware, GKCPTP provides scholarships and loans to deserving students for travel on People to People International programs. During the 2007-2008 year, we provided 25-\$1,000 loans. The students begin repaying these loans in August of each year. Bob Cox, who was handling the loan payments, is no longer able to serve so the chapter needs a new loan coordinator.

Duties:

- To send the students and their parents a repayment agreement and payment schedule when students are selected for the loans.
- To receive the payments from the students and post them on an existing Excel spreadsheet. The spreadsheet will automatically track the payments and balances.

- To contact the student's parents if the payments are not made. (I will help with draft letters).
- To prepare a monthly report to the board on the Student Loan program, using the Excel spreadsheet.
- Work with the team that selects the students, and the treasurer who deposits the checks in the chapter accounts.

I am handling the student loan payments myself at the moment and would be happy to discuss the duties with anyone interested. This program provides a real benefit for young people and is a real asset for the chapter. Please consider volunteering and contact me.
