Dear President Obama & U.S. Citizens,

Our government is making a grave mistake by not discussing China's new **Asian Infrastructure Investment Bank** (AIIB) with the American people. It is these very practices of "secrecy" and "restrictions" that has ultimately lead to China developing the **AIIB**, people's non-trust in the U.S.

**As you well know**, by the March 31, 2015 deadline, Israel, England, Germany, **and many other of Our closest allies** had joined the **AIIB**. - If we do not change our attitudes from ignoring the rule-of-law, "**greed over the common good**," racism, media perversion, arrogance, and hubris towards the world, then we give incentive to other nations, individuals, and businesses, to choose the Chinese yuan currency / **AIIB**, over the U.S. dollar. We will then compromise the very foundation of financial debt support for the U.S. economy, that will threaten **Social Security, Medicare, Medicaid, VA Benefits, U.S. military funding, education, Etc.** So, Americans must be informed to respond to the **AIIB's** upcoming and continuing pressures on the dollar. <sup>1</sup>

<sup>1</sup> **KEEPING THE DOLLAR SAFE**: Our allies are well aware that We have "not yet" reversed U.S. monetary policy from the Bush-era that lead to the 2008 global financial collapse. They don't talk about it, but you can bet that the collapse is one of Our allies primary incentives to join the **AIIB**. U.S. monetary policy must be reversed to protect the dollar / U.S. economy. (See Footnote 11, pg. 6, the three tenets of healthy / organic monetary policy.)

Thus, now, more than ever, We have to be concerned how Our behavior is viewed / perceived by the "outside world." We must shed Our "racketeering mentality" of which eventually leads to the immoral behavior that's realized around the world.

It is only by Americans modifying their behavior in lieu of the **AIIB** that we can prevent diminishing the U.S. financial system, for protecting key American institutions. **For example**, the "quiet, demure, American," who accepts the open corruption / racketeering in American sports cannot afford to remain so quiet, now. Another example is the "silent racist behavior" (racial consciousness) that ultimately becomes apparent to everyone (even when such events are not broadcasted). <sup>2</sup>

Whereby, I am very nervous about the future when learning that many of the U.S.'s closest ally-nations have flocked to join the **AIIB** as "founding members," without regard to U.S. interests. Of course, I warned everyone of Our "allies' disposition" in my Jan. 5, 2015 correspondence on the *Visigoth Effect*; that Our allies **will not** extend a "helping hand" when the U.S. gets into deep trouble. <sup>3</sup>

Of course, that disposition of Our allies is understandable. They have observed for a long time, and been concerned about the hubris of U.S. policy that reeks with greed and self-interest. Now, with the **AIIB**, foreign currencies no longer need to gravitate to U.S. treasury bills. They now can choose the Chinese yuan.

The White House and Congress **are supposed** to be aware of this "national security vulnerability," but it seems our leaders are undermining these dangers. They are so preoccupied with petty political bickering, jockeying for power, while the global financial system is being restructured, **and with the blessings of Our allies**. So, it is most appropriate that Author Michael Pillsbury, others, and myself, have tried to warn Government and fearful Americans of the potential demise of the U.S. dollar. **This American fear keeps people in states of "non-action"** for the further likelihood of the dollar's downfall.

<sup>2</sup> Most recently are the NFL New England Patriot "football deflation-gate" scandal, and NCAA basketball referees openly cheating for the Wisconsin Badgers, for the world to see. Dallas Mavericks Owner Mark Cuban said, "The Kentucky Wildcats were cheated out of history."

<sup>3</sup> These "founding members" include Israel, Britain, Germany, France, Australia, S. Korea, & Italy. By the 3-31-2015 deadline 42 total nations had joined the **AIIB** as founding members.

Mr. Pillsbury says, "... we have to wake-up that the Chinese are not 'backwards anymore,' and that we are falling behind in almost all the competitive indicators... We've got to get our 'own house' in order first, or the Chinese are going to win [this] 'marathon' by default." (*PBS Newshour, Feb. 25, 2015*)<sup>4</sup>

Whereby, public discussion of the **AIIB** would compel Americans to take-stock in how we are viewed by the world. **Another example:** How is Our perverted broadcast media viewed around the world? **See attached the DVD video** of examples of these broadcast perversions.

Here again we must ask, Why have Our closest allies flocked to join the **AIIB**? – For we can no longer bully people into accepting the dollar. **As a nation**, we must now "sell ourselves" to the world. We have to convince people why they should stay invested in the dollar. **And most important**, We have give the "world citizen" reasons to like Us, because he can now choose the dollar or the Chinese yuan.

– **AMERICA'S MOST VALUABLE EXPORT**

Yet, besides exporting U.S. entertainment, Americans do have an important array of exports wanted by the world citizen: Our **true-to-form American ideals, as values**. We have to demand this from our leaders. I.e., **We must start being "true" to these values**.

Thus, **I repeat that these are the sought-after American exports that the Chinese cannot offer.** This is how We survive onslaught of the Chinese currency / **AIIB.**

● **AIIB Require Changes in Unfair U.S. Policies & Behavior to Keep Dollar Safe** (Federal, State, and Local Gov't Must Now Honor the Rule-of-law)

**IT'S VERY SIMPLE:** If investors start fleeing from holding U.S. Treasury Bonds (T-notes, & other U.S. financial instruments), then the U.S. financial infrastructure begins to falter for inability to finance its debt. Again, this fallout would affect **Social Security, Medicare, Medicaid, U.S. military funding, education,** and other critical institutions sustained by America's debt. The U.S. economy will be diminished from where it is, today.

U.S. creditors include: other nations, corporations, pension funds, investment funds, and individuals. The Federal Reserve is forced to limit its issuance of dollars on reduced T-notes issued by the U.S. Treasury. When this happens, less-and-less money can be borrowed for U.S. programs.<sup>6,7</sup>

This "new option" from which investors can now choose the yuan is why We, the citizens, should be concerned about how We are perceived by the world. **Unless We are prepared to go war with China** (and I hope We are not) to enforce the dollar, then the U.S. must change its behavior from bullying other nations, and enter into "courtship" with the world. We must reverse unfair policies and practices that lead to oppressing people, domestically and around the world.

– **Your "Citizen Leadership" is Needed**

And because Government and the U.S. media are acting in the interests of the super-rich, we must exercise our own common sense for helping to "guide" gov't and the media. None of us can afford to standby and allow Our "Homeland" to be destroyed without first

attempting to save the homeland. **This can only be done** by engaging Our gov't, keeping mindful that Government is funded by Our own tax dollars (such as routine deductions from Our paychecks). I.e, since gov't is not using "common sense" today (not considering the real dangers that Our nation is in), then We, as citizens, must engage gov't. - Otherwise, with no "rational direction" we will lose against China.

Wherefore, here is an "editable" list of policy changes I recommend that would improve U.S. standing and popularity in the world. This list may be called, *The Freedom Manifesto*:

**A.** End the practices of U.S. torture as defined by Human Rights Watch;

**B.** Diminish the U.S. immigration crisis by demanding U.S. foreign aid is given to (subsidize) poor people's basic borrowing (banking) needs in third-world countries. These borrowing needs include: schools, housing, starting businesses, farming, etc. The loans' principle & interest payments collected on these loans must be used to pay back any borrowed foreign aid;<sup>8</sup>

**C. To diminish Islamic tensions:** Recognize a Palestinian statehood charter with an *International Marshal Plan* that must include a minimum 20,000 international troop coalition contingency deployed for security;<sup>9</sup>

**D.** Enter into ongoing, formal negotiations with Iran for changing its stance of "death to Israel;" What incentives can the world offer to change Iran's position?

**HONOR THE PEOPLE'S CONSTITUTIONAL RIGHTS (BILL OF RIGHTS):**

**E.** When people are denied jury trials in civil cases (U.S. 7th Amendment), then fine & remove judges and prosecutors from office (fine & remove attorneys from the bar). These fines should be paid to Plaintiffs and defendants that are wronged;

**F.** In criminal cases, stop the coercion / unfair practice of giving harsher sentencing when a defendant chooses to go to trial. Plea agreement offers should equal the conditions for sentencing at trial;

<sup>9</sup> U.S. foreign policy has forgotten its successes of using large security forces to help stabilize prior enemy nations. These include Japan, Philippines, & Germany, that are now successful developed nations with well-entrenched institutions. Not only can this approach be applied for the Palestinians and troubled Middle East nations, but today we can use "international forces" to share the responsibility for peace and security. **It is shown here** that such long-term security (20 years or more) is needed for allowing institutions to develop for stabilizing the societies of nations.

**G.** Require judges to allow all of a party's evidence to be seen before the jury "without restriction," and entered so into the court record. Eliminate lawyer "sidebars," to allow all so-called "side arguments" and "motions" to be heard by jurors. Let the jurors decide these matters from their ordinary's person's point-of-view, pursuant to the uncomplicated language of the U.S. Constitution,

**H.** Allow jurors to ask questions to the "open court" on the issues they are not clear about, prior to "jury deliberation." These questions should be directed to the "trial judge" to answered by the parties;

**I. End police brutality** as a matter of public policy. Municipalities should demand *Police Review Boards* for processing Complaints on police officers and Sheriff Depts. These boards should have Subpoena powers, and with powers to submit evidence to federal and state grand juries; <sup>10</sup>

**J.** Stop criminally "overcharging" police officers who kill unarmed people. The minimum charge should always be "negligent homicide," with the option of "additionally" charging the officer with murder;

**K.** Internet cyber patrons should be allowed to own the "contents" of their accounts. These contents should be released to patrons when the account is closed-out. The website host may not retain these contents;

**L.** Pursuant to the U.S. 4th Amendment, transactional entities (corporations, non-profits, governments, etc) may not share the private information of patrons (or other persons) without the expressed consent of the patron;

**M.** Unless there is "probable cause" (under the U.S. 4th Amendment), stop all telephone and cyber surveillance of U.S. citizens and foreigners outside the U.S. Adopt a policy of mutual trust, unless evidence is otherwise shown;

**N.** Reverse U.S. monetary policy so that everyone "worldwide" can compete equally for the U.S. dollar (this "organic competition" increases value of the dollar by its higher demand, to counteract influence of the Chinese yuan). See Footnote 11, below (**the U.S. will not be fully trusted again until its monetary policy is reversed**); <sup>11</sup>

<sup>10</sup> History proves that police and sheriff departments cannot police themselves. The constant incidences of brutality are routine embarrassments for the America, in lieu of Our boasts of the rule-of-law. The AIBB requires that **We erase the perception** that Americans are hypocrites. – Such evidence is submitted to federal grand juries via the local U.S. Attorneys.

<sup>11</sup> **THE THREE TENETS OF HEALTHY, ORGANIC MONETARY POLICY: A)** Fed (& European) prime interest rate is raised to "competitive level" with other developed nations (China, South America, Etc). This attracts foreign investments into U.S. institutions / communities, and keeps domestic investments within the U.S.; **B)** Reinstate the *Glass-Steagall Act of 1933* that



**O.** End market-industry monopolies as required by U.S. anti-trust laws, including local and statewide monopolies;

**P.** Stop the taxing of services and insurance;<sup>12</sup>

**Q.** Pursuant to Article 1, Section 8, Clause 6 of the U.S. Constitution, re-establish the U.S. Postal Service (USPS) as exclusively a federal agency, such as all other government agencies. Eliminate the "for-profit" status of the USPS as a "private entity" (usps.com), so that U.S. citizens are not under the "constant" undue pressures of rising postal prices. **As intended**, the USPS should be subsidized, where necessary, by the U.S. Government for ensuring all U.S. localities and protectorates are fully served by the USPS;

**R.** Give 60-day public Notice (in newspapers, gov't websites, Twitter, Facebook, Etc) prior to implementation of all new taxes & tax heights;

**S.** Provide / design "equity-based healthcare system" to give incentive for people to maintain their health, leading to lower healthcare costs,<sup>13</sup>

**T.** Honor "retroactive" payment on liens, or criminally charge the judge with fraud who "reneges" on a lien;

**U.** Establish protocols of behavior in a *Manifesto of Decency Standards* for U.S. broadcast media (**For example**: no cussing in talk shows, no nakedness in TV shows, no open homosexual behavior. However, these behaviors may be expressed in distributed motion pictures that are eventually shown on TV.);<sup>14</sup>

separated commercial banking from private investments. This would return global & domestic confidence to the U.S. financial system. *Glass-Steagall* was repealed (stopped) in 1999 by Pres. Clinton & Congress; and **C)** Stop investment bankers from borrowing directly from the Feds (implemented on May 2, 2008 by Ben Bernanke). As prior to 5-2-2008, require investment bankers to return to borrowing from commercial banks (and private lenders). This places all dollars into the open commercial market as intended by the *1913 Federal Reserve Act* that raises further demand / value for the dollar.

<sup>12</sup> Taxing insurance is the most heinous of taxations, because it **is not** even a transaction of services; you are only indemnifying (bonding) any damages that may occur during an auto accident. Thus, the insurance company uses your own money (your paid premiums) to pay for any damages, in addition to premiums paid by other policy holders from the "premium pool."

<sup>13</sup> Equity-based healthcare (EBH), as also recommended by experts such as Aetna CEO Mark Bertolini. EBH allows policy holders to retain ownership of their paid premiums into insurance-company escrows (similar to whole life insurance). With EBH, the insurance company is only one of a "linear" 3-tier payment structure for the payment of claims.

<sup>14</sup> This Manifesto would not be legally binding, but the public would demand broadcast stations to abide by its tenets. The public would also demand local, state, and federal gov't to adopt the Manifesto as a matter of public policy. A petition for the Manifesto should commence.

**V.** Retroactively allow convicted felons to vote when they are no longer on parole. Denying these rights is violation of equal access to the law (the U.S. 14th Amendment, *Clause 1*). U.S. Constitution does not provide for states to remove the rights of citizens;

**W.** To achieve political favor around the world, military drone strikes should only be utilized on battlefields, not in civilian areas. Apply the "Powell Doctrine" of "overwhelming military force" when hunting adversaries in civilian areas;<sup>15</sup>

**X.** Government must "establish & publish" to "continually promote" (or ongoing public education a criteria for the "causes of mental illness." Such criteria should be defined in the various types of mental illnesses, so the public may have ample opportunities to "guard against" the manifestation of mental illness into society.

Most Americans know "in their hearts" that it is the unfair U.S. policies that mostly motivate terrorism. If U.S. citizens "are brave enough" to demand the above policies be implemented, then hate for America would cease (We would then be loved), and **the recruitment efforts of ISIS and al Qaeda** would diminish around the world. - Because **WE ARE AT WAR w/ TERRORISM**, Citizens should routinely submit *The Freedom Manifesto* to their local, state, and federal elected officials until its polices are fully implemented. **We should vote ALL elected officials OUT OF OFFICE if they do not express support for the Manifesto.**

• **AIIB is Another "Visigoth @ the Gate" for the U.S.**

As discussed in my Jan. 5, 2015 letter, the **Visigoth effect** refers proverbially to the German Visigoth tribe that marched through the gates and conquered Rome in 410 AD. The *Visigoth effect* indicates the growing threats to U.S. national security, as many are induced by bad U.S.policies. **Such as America**, today, the Romans would not tend to the economic and security needs of the populations within and around its empire. History shows that whenever wealth is attempted to concentrate to the top-few, it

is "human nature" for those "greedy people" to not tend to their responsibilities to society, at-large. This condition has always lead to war, suffering, and strife, because the "needs of regular people" are left un-attended, with no security, or balance of justice.

The **AIIB** is yet another so-called Visigoth at Our gate. Reversing U.S. monetary policy, beginning in 1999 (by Pres. Obama** chose Ukraine's desire for a Western European deal over Vladamir Putin & Russia's security interests. **4) The Sony** movie / hacking scandal leaves the world wondering why the U.S. gov'mt officially supported a movie of a living head-of-state being assassinated. **5) Many** children within the 12-1/2 million Syrian refugees will someday become terrorists who will attack America and Europe. **6) Unfair** U.S. policies is the source of "hate" that causes homegrown Jihadists to hate "their America." **7) The** quiet policy allowing Caucasian police officers to kill unarmed black men feeds into the Jihadist ideology. **8) A** worsening European economy will create more Jihadists. **9) The** longer that ISIS is not contained, then the above "effects" will become increasingly more difficult for America.

● **For the Above Reasons, Gov't Must Give Status on Operation: Service-member Wellness Maintenance (OSWM) for Our Service-members & Other Rule-of-law**

Pres. Obama, attached please see the circular-flyer featuring *The-Louisville-Underground.org*, showing federal, state, and local governments extensively refusing to honor the rule-of-law in America. Each story in the flyer helps to affirm and exemplify the legacy of hypocrisy of Our touted ideals and values. **I remind you once again** that many of Our closet ally-nations have signed-on to the **AIIB**, for they too are aware of U.S. hypocrisy of U.S. justice and values (**& compromised monetary policy**).

The highest profile of these seven stories is **Story #6**, where the Pentagon / Washington is attempting to steal away my in-unit support system for U.S. service-members, and veterans. This system is called, **Operation: Service-member Wellness Maintenance (OSWM)**, and also dubbed, **Wellness Maintenance**. Most specifically, Sir, **the Pentagon is refusing to give me a "status" on OSWM**, of whether **OSWM** will be implemented for Our service-members and veterans.

I informed you of the Pentagon's behavior in my July 17, 2014 letter (*Certified Mail Tracer 7011 1150 0001 3540 9668*), requesting you to require the Pentagon to provide an "implementation status" on **OSWM**. But I have not heard from you. I have also written to Congress, including **Sen. Rand Paul, Sen. Mitch McConnell, Sen. Elizabeth Warren, Sen. John McCain, Sen. Kristen Gillibrand**, and other Congress persons requesting them to get a status from the Pentagon. But I have not heard from any of these Congress persons, either. - So, it is evident the Government is very interested, and intends to implement **OSWM** without my authorization.

As you well know, **OSWM helps to diminish post-traumatic stress (PTSD) , suicides, sexual assaults, and harassment** for Our service-members while they remain in their assigned military units, including foreign deployments and wartime.

Because **OSWM does not** require doctors, medication, special equipment, or building construction, this "GI maintenance system" is very cost effective, by contrast to current costs to the Pentagon and the VA.

And as I informed you, **OSWM** comprises two specific programs: **1) the Service-members Stressors Identification & Management Program (SSIMP)**, and **2) the Service-members Stress & Anxiety Reduction Program**

**(SSARP). SSIMP** provides "preventive maintenance," based on the medical premise that "all psychological crisis begin with a stressor." So, **SSIMP** assists service-members in managing their stressors before a psychological crisis can occur.

On the other hand, **SSARP** provides "repair maintenance," based on a therapeutic process I developed called, "inflectional therapy" (or **IT**). **IT** is a holistic therapy that effectively treats **PTSD, depression, anxiety, and grief**, of which is also administered within military units parallel to **SSIMP**. Through my 2002 cursory testing of **IT**, as shared with USAMRMC, it has proven to actually cure **PTSD** and cyclical mental depression, and treats anxiety and grief. Wherefore, in lieu of the persistent challenges we face with China's **AIIB**, I beg of your office to require the Pentagon to announce an implementation status on **OSWM**. Please do not allow our service-members to be dishonored and disgraced in this manner. Not to mention that this plagiarism is illegal; my authorization is required for its lawful implementation. Don't let this be yet another stain on the character of American leadership, Our society.

With **OSWM** I have solved life-threatening problems by designing these mission-critical programs for Our nation, and thus I **should not** be treated in this manner. I deserve to be recognized for my hard work and sacrifice **over 13 months**, and as agreed by the U.S. Army.

Even if this matter is kept quiet, such immoral character of America's behavior will still arise within the consciousness of U.S. leadership. An immoral leadership **is not** prepared for China's **AIIB**. Thus, I am asking all U.S. citizens to arise to this occasion. Don't let tainted leadership destroy Our U.S. homeland. To speak out on this matter, **to protect America's most sacred value of honoring Our service-members and military veterans**. Don't let this be another lie from Our nation, Sir.

#### **- Other Rule-of-law**

As shown, TLU ([The-Louisville-Underground.org](#)) showcases other stories of corruption and injury in America. Here in Kentucky, **the rule-of-law is being ignored** by federal, state, and local law enforcement, and elected officials. TLU further depicts how America must change its current disposition respecting human rights. We currently boast to the world that

we honor the rule-of-law as one of Our highest values, but the world knows this is not true.

As stated, in preparing to battle the **AIIB**, we have to become true to Our values, so the world will support Our challenges against the **AIIB**. **In fact**, America lacking the rule-of-law is Our most disappointing failure felt by the world. For, everyone looks to America to set this example, since the world is suffering so much.

The most horrific feature in TLU is **Story #1** on Ms. Connie Marshall. This is an account of very old racism in Louisville. Ms. Marshall is being stalked and harassed by particular police officers within the Louisville Metro Police Dept (LMPD), because of her court claims of harassment filed against the LMPD. Then, on Dec. 19, 2014, Washington's **General Accounting Office (GAO)** affirmed the nation's need for an emergency protocol plan. Thus, I hereby request that **NUPIP** not be turned into a "political football." It is critical for the American people to pressure Our elected officials to implement an emergency protocol plan as soon as possible for the challenges we face. (See
