## New Entry: Are you prepared for your audit?

## Most Common AUTO Failures

### Know the warning signs

- ⚠ Failing to implement an alcohol and controlled substances testing program **(Applies to CDL Drivers.)**
- ⚠ Failing to ensure your drivers have a valid driver's license or commercial driver's license with the proper class and endorsements. **(You must pull MVRs.)**
- ⚠ Failing to maintain Records of Duty Status or Time Cards. **(All drivers, even local drivers, need a form of hours of service. These range from Log Books to Time Cards. Note: time cards must meet a specific requirement or they won't be accepted and then you will fail)**
- ⚠ Failing to implement a PM program, document and repair your equipment with severe defects that are noted on driver vehicle inspection reports or other inspection reports. **(These specific violations are listed in the Out-of-Service Criteria.)**
- ⚠ Failing to Periodically Inspect your Commercial Vehicle Power Units and Trailers. **(Periodic Inspections must be conducted annually by a Qualified Inspector. Not all mechanics are qualified. There must be knowledge of the specific regulations.)**
