

GOVERNMENT AFFAIRS UPDATES

NSPS - NSPS is still in the works and really nothing new to report on it, but still waiting for the final version to be published. The main issues are what some of the states want, and what is viable and can be done. Also EPA came out in Dec. with new PM standards for the states. DOE RULE - We won, at least temporarily. The DOE can always come back with new rules that could affect us again. They will have rules in the future that will affect heater rated units with some sort of efficiency testing for them. But for now, decorative gas units and gas logs are off the table. DOE did not go back to the court to ask for the court to rethink their decision in the allotted time frame.

UL127 GASKETED GLASS DOORS HPBA is working on getting the issue with the gasketed glass doors on fireplaces changed, but it probably won't happen until 2014. For more information that may be available, check with Tom Stroud at stroud@hpba.org.

CSPC - Beginning in 2015, all glass fronted gas burning units must have a safety barrier shipped with the product. In the meantime, please inform your current customers and pass customers of the importance of watching their children and grandchildren around all burning appliances.
