

Stove Change Out News

Still nothing new on the change out, other than it looks like this change out will happen a little later than anticipated, maybe at the earliest late next year. Things are still moving forward, just at a slower rate. Since the change out will cover the northeastern corner of the state along with some other states in the Four Corners area, a lot of the area is home to the Navajo and Hopi Indian reservations. The final details are not set yet, but things like education are being talked about. Some of the change outs could include coal stoves along

with wood, gas, and pellet units.

In other change out news, there will be a change out in Colorado starting soon, and in California, the governor has put 40 million dollars into his budget this year for change outs. That may not pass, but it means that states are looking more and more into stove change outs as an alternative to help the air quality. Send questions to me at ahpba@outlook.com.

GOVERNMENT AFFAIRS UPDATES

NSPS - NSPS is in, and 4.5 g/h or less is the magical number for Step 1 and this covers all wood stoves, wood inserts, and pellet stoves.

Dec. 31, 2015 was the last date to sell any non-certified units. Also of importance is having the installation manuals close by the displays so potential owners can inspect it. There is always the possibility of EPA enforcement people to show up after the first of the year. **BE PREPARED!** Hang tags are not required in Step 1, but will be optional in Step 2. DOE: DOE finally had a seat down meeting with the HPBA. Will have to see what happens in the future. Nothing new to report as of right now, but we will let you know as soon as we have something.. For more information concerning the DOE, please contact Ryan Carroll at carroll@hpba.org.

CSPC -The gas unit barrier issue is still being talked about by media. The latest Consumer Report's has an article in it about the barrier issue. So just be aware of how you can handle a question concerning units you sell and other units, especially units manufactured before 1-1-2015. NFPA 211: The NFPA 211 has modified the rule to allow decisions to be based on a decision by a qualifying agency, such as NFI or CSIA. Also the rule about gas logs being certified for each unit that they are installed has been deleted, and the wording has went back to what it has been for the

CALIFORNIA BLOWER DOOR RESEARCH: A new research effort to investigate the positive impact of a properly installed gas insert on home heat loss is underway with the backing of the HPBA Gas Hearth Appliance Section and administration by HPBA Pacific. The program enables dealers to give their customers a \$200 rebate in return for allowing a subcontractor to perform before-and-after blower door tests on the home to document the effects of installation of a gas insert. HPBA Pacific, which administers the project, has created a new website for this project at <http://gasinsertproject.com/>.
