## GOVERNMENT AFFAIRS UPDATES

**NSPS** - HPBA has submitted their comments to the EPA concerning EPA's proposed new standards with NSPS. The comments totaled 150 pages with 20 attachments. The key points in their comments were: EPA needs to allow transition time for product sell through, delays in effective dates, grandfathering in of products voluntarily certified, strongly opposing steps 2/3 standards proposed, uncertainty of the proposed test standards, costs associated with meeting steps 2/3 to the manufacturers, etc. HPBA is also still working with EPA to get performance standards that will work and not put a lot of small companies out of business. **DOE**: As I stated in the last newsletter, HPBA has submitted a response to DOE latest proposal that would give them control over regulating all gas burning appliances including decorative units and gas logs. They are still waiting for a respond from DOE. In the meantime, HPBA is working with some Representatives in Congress on a bill, HR 3761, that would protect decorative gas appliances from improper regulation. The wording of this bill had to be amended to take in the new rules that EPA came out with at the end of Dec. 2013. Chances of this legislation being passed this year is very slim, but it will lay the groundwork for next year. So please contact your Representative to let them know that we need their support. **TAX CREDIT ISSUE**: Also contact your Senator about Residential Energy Efficiency (25C), which includes a tax credit for biomass-fueled stoves. It is currently in the Senate Finance Committee. Rachel can help you with contacting your Senator too.

**CSPC** -Please inform your current customers and past customers of the importance of watching their children and grandchildren around all burning appliances. **NFPA 211**: The NFPA 211 committee met in Denver recently to start the revisions to the current NFPA 211 rules which is revised every 3 years. The main issues that have come up is that restricting use of certain parts for pre-fab fireplaces especially in reference to older units where there are no replacement parts made for these units, rain cap heights, and wall pass-throughs. HPBA will continue to monitor these proceedings.

**LOCAL ISSUES**: Maricopa County will still be issuing no burn day warnings in the coming months, and of course, that will continue once our cool weather comes back. Members not in Maricopa County, you need to be aware of what is going on in your cities and counties that could affect you in the future. If you hear of something, let me know, or let HPBA know.
