Another View of Lewis and Clark

When I saw the notice on Kira Gales' blog, www.lewisandclarktravel.com, that Stephanie Ambrose Tubbs would be giving a pre-publication presentation on her book in Lincoln Nebraska, I decided to attend. I am glad that I did.


Why Sacagawea Deserves a Day Off is a collection of essays that Stephenie Ambrose Tubbs prepared for speaking engagements leading up to and during the bicentennial of the Lewis and Clark Expedition. After some additional work, these presentations are now available in one paperback book.

A conversation with Stephenie Ambrose-Tubbs is always lively and engaging. The only way our conversation after her presentation in Lincoln would have been any more enjoyable is if it had occurred around a campfire along the Missouri river. The reader will have the next best thing to a campfire conversation with the author as she brings the same enthusiasm and insight to the essays in this book.

The book of 11 chapters covers a wide variety of topics. I read with special interest chapter eight, describing her thoughtful theory that Meriwether Lewis likely suffered from a form of autism called Asperger's syndrome. Her theory has caused me to think about the potentially additional burden Lewis carried since I read that chapter and therein lies the value of this book. It deepens our understanding of Lewis and Clark and makes the reader think. The authors' sometimes unconventional approach to history combined with a desire to preserve the story and the wild places remaining along the trail for future generations are evident. "*Why Sacagawea Deserves a Day Off*" give us a fresh appreciation for one of America's great stories and for the last best places in which we can still share them.

I am glad that Aunt Lois Ambrose loaned her Biddle edition of the Lewis and Clark journals to Stephenie's father on that summer evening in 1975. That legacy of sharing is extended to us with the publication of this book.
