- This puppy is sold as "pet quality" only.
- Puppy is warranted for twelve (12) months from time of purchase against any fatal or life altering congenital disease including:
 - ~Severe/crippling hipdysplasia, any organ, spinal or neurological problems.
 - ~Non-life threatening conditions are not warranted.
 - ~Buyer must show proof of severe congenital disorder from two (2) different licensed vets before the age of twelve (12) months. If buyer decides to keep the puppy, half the purchase price will be refunded or puppy will be given back to breeder and a new puppy will be granted to buyer within one (1) year of diagnosed disease at no cost to buyer.
- All vet expenses are buyers' responsibility.
- Any physical problems which are caused by accident, injury, neglect or poor diet or care are not covered in this contract.
- Parents DNA tested through Embark.
- Parents are heart, eye and patella tested.

Buyer Agrees:

- To take puppy to their own vet within ten (10) business days of purchase and to maintain regular veterinarian care.
- To have puppy spayed/neutered by 6-12 months of age.
- If buyer decides he/she cannot keep the puppy for any reason other than life threatening congenital disease, then it is encouraged to return puppy to breeder or find a safe, suitable home. No refund will be given unless breeder decides otherwise.
- It is further understood, seller is not responsible for any vet or medical expenses once puppy is in the buyers care.
- This contract only applies to original buyer.
- By fully reading and signing this contract, buyer agrees to all terms and conditions implemented in this contract.
