## **EVENT DETAILS**

- Vendor set up is from 9:00am 4:00pm on Friday, September 8. Please arrive early to unload for set up and remove your vehicle to an outside parking area when finished unloading. No large vehicles will be allowed to stay as part of your vending area unless approved by event staff.
- For pedestrian safety, vehicles are not allowed to park inside the park after 2:00 pm.
- Setting up the night before is allowed.
- Your vendor location will be assigned to you the evening before or the morning of the event and be determined on a first come first serve basis.

By submitting this agreement for Dinosaur Stone Age Stampede, the undersigned vendor ("Vendor") agrees to be bound by each and every term set forth herein and the terms and representations set forth in the Application, which is incorporated herein by reference as though fully set forth. If the Vendor violates any term of this agreement and/or the authorized agents of Dinosaur Stone Age Stampede may within their sole discretion and at any time (1) terminate this agreement, (2) require Vendor, immediately upon notice of violation of this agreement, to cease operations and vacate the premises, and (3) forfeit any and all fees paid for the right and privilege of participating in Dinosaur Stone Age Stampede. This agreement represents the entire agreement between Dinosaur Stone Age Stampede and the Vendor and may not be amended without the mutual consent of both parties set forth in writing and signed by authorized representatives of Dinosaur Stone Age Stampede and the Vendor.

- 1. Dinosaur Stone Age Stampede agrees to provide each Vendor of Dinosaur Stone Age Stampede Vendor Show with one assigned space(s).
- 2. Vendor agrees to obey all rules and instructions as directed by the Festival Director. Any failure to strictly adhere to such rules or instructions may result in the immediate termination of this agreement and immediate forfeiture of any and all fees paid.
- 3. Vendor hereby acknowledges its liability, and agrees to compensate Dinosaur Stone Age Stampede, for any damage(s) caused by, including but not limited to, its representatives, agents, employees, volunteers, members, vehicles, equipment, materials and objects to the environs and infrastructure of Cady Park which causes Dinosaur Stone Age Stampede to pay for repair, replacement, or other remuneration to the Town of Dinosaur for such damage to the environs or infrastructure of Cady Park.
- 4. As a courtesy to other vendors and festival participants, any amplified sound or loud noise from Vendor's space is prohibited.
- 5. Only Dinosaur Stone Age Stampede and those individuals or groups which have signed Food Vendor Agreements shall be permitted to serve, sell or in any way provide beverages (including water) or food at any site or operation of Dinosaur Stone Age Stampede Vendor Show. Violation of this provision and/or any portion of the health code are grounds for immediate expulsion from the festival grounds.
- 6. Dinosaur Stone Age Stampede reserves the right to prohibit, within any booth or on the festival grounds, the display, advertisement, or other promotion of any business, company, or organization which may be in conflict with a current Dinosaur Stone Age Stampede sponsor. Any questions concerning current sponsors should be directed to the Festival Director prior to the event.



- 7. Vendor shall not display, offer for view or sale any illegal or contraband items. The laws of the State of Colorado and local ordinances of the Town of Dinosaur shall control. Vendors shall not display, offer for view or sale any items that are unlicensed and/or copies/interpretations of licensed or registered items at any site or operation of Dinosaur Stone Age Stampede.
- 8. Vendor acknowledges and understands that it is solely responsible for the collection of any sales or use taxes and shall in no way hold Dinosaur Stone Age Stampede or its representatives responsible for any type of permits other than for the festival itself.
- 9. Vendor is solely responsible for the security for all its items at the festival location at all times.
- 10. We make no representation or guarantees towards actual festival attendance.
- 11. Vendor understands that Dinosaur Stone Age Stampede has no control over weather, acts of God, acts of terrorism, or governmental intervention, or any other cause that may prevent, and or interrupt, the event, and participants shall hold Dinosaur Stone Age Stampede harmless for any losses that could arise because of such event. 12. Dinosaur Stone Age Stampede reserves the right to place Vendors in booth locations at its complete discretion. Dinosaur Stone Age Stampede shall have sole and complete authority to place the participant in any location contained at the event, irrespective of the participant's request.
- 13. Vendor upon vacating its space(s) shall ensure that such space shall be free of any and all trash and refuse with such being placed in the appropriate containers. Failure of the Vendor to clean their space may result in future refusal of Vendor application.
- 14. Vendor certifies that it maintains adequate liability insurance to cover any and all occurrences which may result in the damage or injury to any person or thing within the confines of the Vendor's space or as a result of the Vendor's actions at the festival.
- 15. Vendor will indemnity and hold harmless Dinosaur Stone Age Stampede from any and all claims, actions, judgments, including all cost of defense and attorney's fees incurred in defending against same, arising from and related to the Vendors participation in the event. Vendors actions include the acts of Dinosaur Stone Age Stampede agents and employers.
