### **Introduction**

1. If the above Gov't officials will not straighten-out voting, then they are violating law working against the interest of voters and thus they have to leave office. And they have to leave office if they won't stop the inflow of illegal migration that's destroying the U.S. tax base. Where the popular Kentucky Gov. Andy Beshear is supporting these illegal policies, then he, too, must leave office. For, otherwise, he is deceiving **The People**.

2. The herein Criminal Complaint identifies specific dangers that we face for the November elections. The Biden-Harris administration is continuing to destroy our institutions and **no doubt** are attempting to disrupt the November 5 elections.

3. Pursuant to prior warnings of Biden's "conviction trap for Trump" and attempts to assassinate him, law enforcement must intervene and warn the public of the dangers of this Complaint. Even at this short hour, to protect the family of Donald Trump and the nation, Mr. Trump should withdraw from the presidential race and allow Robert Kennedy, Jr. to resume running to become President. Law enforcement must stop the conspiracy to destroy the U.S. **Probable cause:** Biden-Harris providing unlimited free rent, food, jobs, and transportation to the millions of illegals is collapsing the U.S. economy. This treason is the wholesale misappropriation of tax dollars that requires removing Biden and Harris' from office. And Congressmen as Republicans and Democrats are supporting Biden-Harris. They must be brought-in for interrogation. These include the congressmen from Kentucky: Sen. Mitch McConnell, Sen. Rand Paul, and Rep. Morgan McGarvey. The three conspiracies identified herein are further evidence of the intent to destroy the U.S. To wit:

## 1. Officials Illegally Using Courts, Etc to Force County Clerks to Certify Elections

1-A. On August 18, 2024, Rachael Maddow (MSNBC *Rachael Maddow Show*) introduced Noah Bookbinder, President of Citizens for Responsible Ethics in Washington (**CREW**). CREW released the report, *Election Certification Under Threat (as CREW Report)*, to earmark its perceived dangers of county clerks refusing to certify election results. **Quite suspiciously**, the CREW Report is undated and does not state any authors therein. Bookbinder claims it's a growing problem and that county clerks should be jailed for refusing to certify elections. I.e., they should be

forced to certify even if they disagree with election results or how elections are conducted. The CREW Report recommends the same, to sue or criminally charge county clerks and board members (**election officers**).

1-B. **The CREW Report's Catch-22:** In the Report, in eight States, 35 election officers were held accountable for not certifying elections. Their refusals mostly dealt with mistrust in voting systems\processes such as the voting machines. This presents a catch-22 for election officers. For, certification confirms the election results are true and accurate. It is the last safeguard for protecting elections; it is not a ceremony. To certify but while evidence that the election results are false is to “falsely certify” the results, to commit criminal fraud. Wherefore, it is illegal to force clerks to certify, to force false results..

1-C. **It is election interference.** In States such as Kentucky, it means there's no agreement on integrity of the election process. This is problematic prior to campaign seasons when voters are told to believe the elections are legitimate. It demonstrates that gov't officials are ramming through questionable election processes of which astutely honest election officers are not accepting. Yet despite the controversies, governors and Secretaries of State approve the “not agreed upon” election processes. So, the problem is with corrupt politicians, not the hard working county clerks.

1-D. **For example**, on page 6 in the CREW Report, the 5th bullet partly states:

**“ . . . If state authorities fail to act, then federal authorities should pursue civil and criminal remedies to protect federal voting rights.”**

1-E. Footnote 19 on said page 6 is concerned about election officers certifying the wrong candidates, a hint toward U.S. Attorney General Merrick Garland to enforce the installation of leftist candidates. This, too, is illegal, as the county clerks must be free to do their jobs for proper certification of vote counts for the voters.

1-F. Feasor **Brian Kemp, Governor of Georgia**, is one of the officials planning to force election certifications in the midst of county clerks having evidence that elections are questionable. Here, Gov. Kemp would interfere to influence the election. I.e., officials cannot legally interfere with elections but must rely on the evidence of “election officers” that certifications are true and correct, or NOT.

1-G. In Kentucky, pursuant to Case 23-ci-6012 in Jefferson County, election officials are violating election laws KY Const. §147 and §148 for fraudulent





elections. These feasons are: **Michael A. Bennett, Andy Beshear, David J. Hale, Annie O'Connell, Patricia Morris, Michael Adams, Bobbi Holsclaw, Natalie Johnson, Taylor Payne, Jason Snyder, and Jennifer S. Scutchfield.** Said §147 requires that all ballots are to remain confidential so that election officers cannot know of whom casted the vote. Said §148 bars county and State officials from counting the votes. Precinct officers must live within their respective precincts so that voters cannot vote outside their precincts; these are called **neighborhood-voting precincts (NVPs)**. Since 2020, the feasons have refused to enforce §147 & §148 that renders all Kentucky elections invalid, illegitimate. And they are doing the same for the November 5, 2024 general election.

Feasor Secretary of State **Michael Adams**

cannot legally certify as true and valid the November 2024 election in Kentucky.

1-H. Said feasons **Johnson, Payne, Snyder and Scutchfield** are attorneys representing their respective clients in said lawsuit (**Beshear, Holsclaw, Bennett, and Adams**). **By ignoring §147 & §148**, they are knowingly allowing their “conspiratorial clients” to perpetrate fraudulent elections. And wherefore, these attorneys are complicit with the conspiracy to disenfranchise\defraud the voters. Properly so, these attorneys are required by law to inform their clients that Kentucky elections are not legal without the operation of §147 & §148. They cannot legally cooperate with fraudulent elections and must inform the public so.

1-I. In December 2023, Feasor **Annie O'Connell** in State court, the original trial judge, by her conflict-of-interest with her father as County Attorney, Mike O'Connell, transferred Case 23-ci-6012 to Feasor Patricia Morris, as the trial judge in the State court. However, **O'Connell or Morris violated court procedures by not informing [Plaintiff] Cobble of the transfer** that prevented him from prosecuting the case. Here, **O'Connell and Morris** obstructed justice.

1-J. **Then to further commit obstruction of justice in 23-ci-6012**, on November 6, 2023, Feasor **Michael A. Bennett** illegally removed it into federal court as federal Case 3:23-cv-579 to Feaser federal judge **David J. Hale. Hale** held-up the case despite repeated written warnings from Cobble that elections in Kentucky are illegitimate. On September 23, 2024, only upon public pressure, Hale remanded (sent back) the case to State court. In State Court, Cobble filed an October 17, 2024 **Notice to File Criminal Complaint** (Page 1 attached as **Attachment 1**) where Feasor **Patricia Morris** as the trial judge refused to enforce



§147 & §148. In Kentucky, **Morris** is the latest feasor interfering with an election to commit obstruction of justice and election fraud.

1-K. **Attachment 2** is one of two liens for removing Feasor KY Secretary of State **Adams** from office, Lien 2022-3233726-12-001. Despite his soft disposition with the public, these undisputed liens are “legal admissions” by **Adams** that he is defrauding the elections to disenfranchise voters.

1-L. So with the above **glaring criminal behavior of the feasors, prosecutors and courts do not have jurisdiction to compel certification unless there is** probable cause **that a county clerk\election officer is doing an illegal act.** Instead, clerks have unfettered jurisdiction to carry out their duties to ensure the integrity of elections. CERTIFICATION IS NOT CEREMONIAL BUT NEEDED TO CONFIRM ACCURACY\TRUTH IN THE VOTE COUNTS.

► **KY law: State & county officials shall not be election officers, PERIOD.**

1-M. Instituted in 1891 under common law, §147 & §148 provide NVPs (neighborhood voting precincts) that prevent the conflicts-of-interest of States and county employees handling the votes. This conflict-of-interest places voters and the nation at-risk of the herein specified corruption. **Example:** Today in destroying the nation, Republicans and Democrats are allowing illegal immigrants to overrun U.S. citizens. But duly elected officials by NVPs would not allow this migrant catastrophe. Thus, **ELECTIONS WHERE GOV'MT OFFICIALS COUNT AND HANDLE THE VOTES ARE UNLAWFUL.** For, California, Oregon and Washington State must remove this conflict-of-interest and reinstitute NVPs.

► **How We Get Vote Counts on Election Night**

1-N. Certification **did not** become a procedural problem until politicians began to dicker with the traditional NVPs that **decentralized and protected voting processes.** I.e., to remove the power of counting the votes from neighborhoods. And yet the other great advantage that everyone is forgetting is that NVPs, besides being mostly trouble-free, always rendered the voting results on Election Night or the day after. How? Because each county is divided into small enough NVPs (in KY with no more than 700 voters) so the RPOs (resident precinct officers) can complete the counts on Election Night. So, the question is: **Why have Gov't officials abandoned this nearly perfect system?** ANSWER: Such as in Kentucky, today, so the politicians can manipulate the vote counts to install their candidates instead of candidates by the will of *The People*, i.e., by NVPs.

1-O. **CONCLUSION of criminal charges and removal from office** Feasors **Brian Kemp, Michael Bennett, Andy Beshear, David J. Hale, Annie O'Connell, Patricia Morris, Andy Beshear, Michael Adams, Bobbi Holsclaw, Natalie Johnson, Taylor Payne, and**

**Jennifer S. Scutchfield** are committing election fraud, conspiracy to commit fraud, official misconduct, and violation of their Oaths of Office. And they each commit treason with Joe Biden and Kamala Harris where they support the invasion of illegal migration that must destroy the United States. See **Affidavit-1** attached.

1-P. Credentials of the CREW Report are lacking, as its premise violate basic law as well as common law. Per the above Kentucky example, there is no justification to criminalize certification but it's an attempt to highjack vote counts from county clerks doing their jobs. Where the conflicts-of-interest exist against the interests of voters without NVPs, politicians in November 2024 intend to cheat to impose false election results. Criminalizing election certification is for that purpose.

## 2. **Fake Photos & Info in Kamala Harris Book; No Conclusive Evidence of Harris Born in the U.S.**

a. Was Harris family planted in the U.S. by operatives in the Democrat leadership? . . . as acts of treason?

b. FBI & DoJ Must Takeover the  
Candace Owens Investigation

2-A. Certainly, the FBI and DoJ (U.S. Dept of Justice) are aware of the "must see" investigation on Feasor **Kamala Harris** by Candace Owens (see C. Owens Podcast, episodes 78, 79, & 59 - Youtube). It seems **Harris was not** born in the U.S, but planted and groomed from childhood by the Democrat leadership and Marxists. She was very likely born in India. Here, Feasor **Joe Biden** and others are culpable for treason. **So why haven't the FBI and DoJ taken-up this investigation?**

2-B. Not only is the family tree of **Harris** not making sense, but too, her 2019 book, ***The Truths We Hold, An American Journey***, is filled with fake photos & and information of black folks that **Harris** claims are her relatives. In the photo shown on this page, Harris falsely states the woman is her grandmother, though her grandmother died four years before **Harris** was born. And as of yet, the info on her birth certificate cannot be verified.

2-C. **Just as baffling** is the mystery of her alleged father, Donald J. Harris, of which Owens says there's no early-recorded history of the father. For example, she

could not find a birth certificate on him. Owens suggests that Donald Harris is not his real name as no family photos could be found of Harris with his mother and father. In the July 23, 2024 article of the *Irish Times*, Mr. Harris didn't even mention his father, the same incomplete results from Owens. **Amongst other inconsistencies**, the *Times* article states: "*The direct genealogical link between Ms. Harris and Brown is not considered comprehensively proven.*" I.e., though Mr.

Harris claims that Christiana

Brown is his maternal grandmother, it's not conclusive.

So, who helped the Harris family to set-up their phony lives in the U.S.? **Who?**

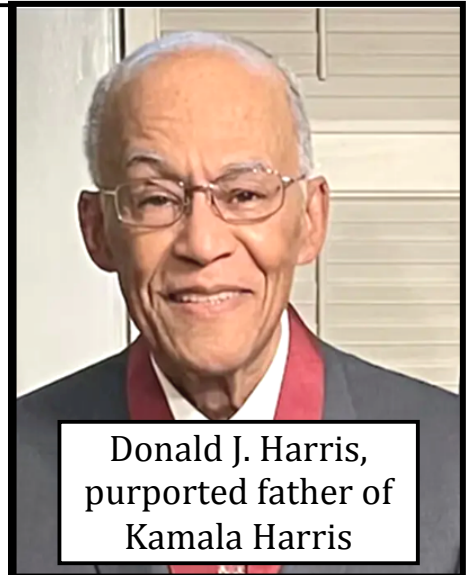
2-D. This cover-up suggests that Harris was not born in the U.S. but planted in the made-up Harris family. As alluded, most conveniently is that she is likely from India. For example, Owens revealed that Donald Harris is a

devout Marxists and her mother, Shyamala Gopalan, from India, comes from a family of devout Communists. It was also very convenient that Kamala met California politician Willie Brown who ushered her into California politics. And though she was very unpopular as a 2020 presidential candidate, **Joe Biden** still chose her to be Vice President. 2-F. **CONCLUSION:** The possibility is real of electing an unqualified, **treasonous** imposter into the White House, a **Manchurian candidate**. The above probable cause warrants the DoJ and FBI taking over the Candace Owens investigation, to bring-in **Harris, Biden**, and her alleged mother and father for questioning. **For the truth, this matter demands a forensic investigation.**

► Claiming to be the father of Kamala Harris, we don't really know whom that alleges to be Donald J. Harris. The evidence is showing the Harris family was planted to destroy the United States.

3-B. And of course, for Biden-Harris determination to hold-on to power is why the nation must be prepared for civil strife. 3-C. She is calling him “Hitler,” “he will end democracy,” “he’s a fascist,” “he is increasingly unhinged,” “he’s an enemy from within,” “we’re not going back,” etc, etc. These unsubstantiated disparaging remarks are signs of Harris lacking confidence to prepare the public for **“He’s too dangerous for me to certify the election.”** She will attempt to not certify the election that would ignite civil war.

3-H. **CONCLUSION:** Any initial signs of violence should be linked to the inciting remarks of Harris and Tim Walz. Upon Harris refusing to certify a Trump win without the probable cause of election fraud, law enforcement must remove Biden and Harris from office. And pursuant to above Section 2, law enforcement should bring them in for questioning. Is the Harris family line her true identity? . . . and was she born in the U.S.?



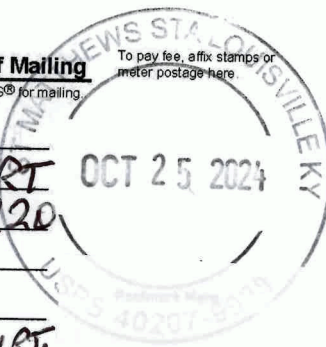

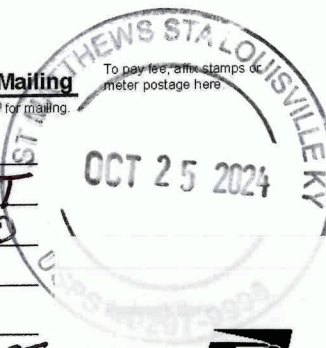
