I. Congregational Second Quarter Meeting:

The congregational meeting will be held August 22, 2021. Vice President Solberg will be in charge.

II. New Youth Director

Ikeria Green was identified as a candidate for the Youth Director position. Green worked for the YMCA this past Summer. Green joined TOL two weeks ago. There were only eight children who went to summer camp at Luther Hill this past Summer. Green works full time for C.I.S.D. and will be asked to work part time at TOL with

a minimum of 15 hours a week. The 2021 budget for a youth director is \$8,000. A motion was made by Lemaux and seconded by Solberg to offer Green the position of Youth Director with a salary of \$14.00 per hour and a start date of 08/23/20221. Prior to a vote, there was discussion on this and Bliese recommended the salary be increased to \$15.00 per hour. Solberg also agreed to be a mentor along with his wife to Green as she is still working on her college degree in education. The motion by Bliese was then amended to reflect a salary of \$15.00 per hour and was seconded by Schaper. All were in favor and the motion passed.

H. Pastor Chris led council with the Lord's Prayer and Jack Zimmer adjourned the meeting at 8:09 PM.
