A. The meeting began with an opening prayer by Ryan Dockery.

### C. Discussion agenda

#### 1. Old Business

i. Chuck Will and John Baumgartner have secured quotes for repairing or replacing the AC unit in the office area. This has taken longer than they both expected due to Carrier not getting back to contractors. The pros and cons of replacing or repairing were discussed. The view is that the AC unit needs to be replaced. The motion for the congregational meeting will be that up to \$30,000 be spent to replace the AC.

#### 2.New Business

i. Jim Voelz moved and Kirk Helberg seconded that \$750.00 be given to Ryan Dockery for his moving expenses to Messiah Lutheran Church in Washington. All were in favor. The motion passed.

- ii. A discussion was held on carpet cleaning in the office area and the narthex. Kirk Helberg will attempt to use his carpet cleaning machine from home in the next week.
- iii. Jim Voelz stated that the pledged offerings are running at 107%. Non-pledged offerings are at 80%. The summer offerings are better than last year.
- iv. Heidi Beckham reported that on-line giving is now ready to convert folks to Vanco. Dennis asked Heidi to set up The Well service for texting of offerings.
- v. A discussion was held regarding the Lilly Grant and Pastor's travel, lodging and food expenses. Linda Baumgartner shared that she will ask Lilly to transfer the remaining of the travel budget to the food and lodging line item. This will help to cover the expenses during Pastor and his family's expenses when they travel to the west coast. Council stressed that once the grant monies are expended that Pastor recognized that the remainder are his personal expenses.
