Dear Mr. Turner,

1. Your office has not yet responded to Our **July 3, 2013 Request for Investigation** into the June 19, 2013 degrading, racially-charged death threat to Ms. Connie Marshall and her daughter, and of the ensuing racketeering of which she and others are being subjected to. On **July 4, 2013**, Ms. Marshall received yet another racially-charged death threat with the same demand as the 7-19-2013 threat. See the 7-4-2013 death threat attached, hereto, as another entry as evidence to the FBI.

2. Both threats demand Ms. Marshall to change her "not guilty pleas" to "guilty," in cases 12-F-07230 and 13-M-01390. We explained to the FBI the Jefferson County district court (Judge Sean Delahanty) and officers of the Louisville Metro Police Dept. (LMPD) need for Ms. Marshall to plea guilty, because there are no actual charges filed against her in 12-F-07230 and 13-

M-01390. They believe not guilty pleas will absolve them of any wrongdoing. - The 7-3-2013 *Request* explains that this is an ongoing racket routinely perpetrated by the court system, the court clerk, Jefferson County Sheriff Dept., and the LMPD. **Check the court records for verification.**

3. Furthermore, pursuant to the 7-3-2013 *Request* to you, Daniel Cobble is still being denied entry to the Jefferson County Courthouses for court appearances and attending public hearings. These are stark violations of his First Amendment rights to process his grievances before the courts, as well as his right to assemble at court proceedings.

3. Whereby, Mr. Turner, we demand again, here, that your office conduct its official mandate of investigating these matters, including allowing the victims in these *Requests* to provide the further evidence of Our injuries. You are required to protect us, and protect our rights upon making the FBI aware of the evidence. - Whereby please let us hear from you. **Your are required to address our suffering**, including this persistent harassment resulting in blockage of our constitution rights. - *Thank you.*

I cant wait to put a bullet between ur eyes u dumb coon. everyone laughs at u nigger. were gonna torture u so bad and tracy until both of u die and then we'll say u killed ur daughter and urself :) oh yeah connie u think im the only one in on this? theres 7 guys here right now and we're all gonna get u nigger. ur fuckin done for - u hear me. me and my buds cant wait to beat ur ass again-just like last time. except this time ull never be able to move again when we're done with u. dont u get in connie? nobody wants to help u - ur dead. i cant wait to beat the living shit out of u and teach u that u r a SLAVE nigger. we watch ur house all the time. we kno everywhere u go. we can kill u anytime we want to and WE WILL. i fucking promise u we will never stop until ur dead. and guess what nigger - theres so many ways we can do it. we can say u grabbed for my duty weapon and had no choice but to kill u.. or id rather just give u a good ol' fashion LMPD lynch and throw ur ass in an alligator pit - and in a day - ud be alligator SHIT. nobodys gonna help u nigger. we're gonna put u away forever, either in jail or in the nuthouse or in a box in the ground. u better stop fuckin with us connie - we know everything about u - i have all ur information: all ur shit is right here. me and the boys were maybe thinkin it was time to take out some loans in ur name haha maybe make u lose ur house. woudya like that coon? oh god i cant wait to smash ur skull in coon. u fucked with the wrong group connie. we're the good ol boys of kentucky and nobodys gonna stop us. hal u think they give a shit about u? we have u so discredited now that we can run u over in the street and everybodys gonna believe us. so just wait. one day ull make a mistake and we'll be watchin and we're gonna get u. ur gonna scream and beg as the blood runs down ur coon body and we'll just choke u more and more and then move on to tracy and kill both of u. i really hope we get the word connie - and even if we dont theres ways we can get around that and just kill u - make u disappear. ur gonna disappear one way or another. ur best bet is to fuckin plead guilty to everything and check urself into the hospital. if u do we'll leave u alone. if u dont we're gonna kill u - flat out coon - ur dead - u got that? ur dead yeah and my partner already put u in NCIC connie - u know what that means? no matter what happens in court u cant get that out of there! every fuckin time u get pulled over ur gonna get fucked so bad and thrown in jail. and there's nothin no dumbass judge or court can do about it. so ur already fucked u might as well give up nnow while ur still ahead before we kill u i cant wait to crack ur skull - one part of me just wants u to keep going and keep fightin so WE can tear ur ass apart. i guarantee there will be high fives at the station when that happens. we're still laughin at u connie - u are DEAD as far as we are concerned. i cant wait till the day i can get my hands on u. - and this isnt a threat connie - its a promise - we're gonna kill u. sooner or later u will die and then ull learn to appreciate the power of the LMPD - we are the real government nigger.. u are nothing. u are on the federal targets list too - so running isnt gonna help u nigger. just kill urself before we do it for u
